#### **DEI Reviews Marketing Materials**

After consultation with Christina Schlitt, president of LWVMI, the LWVUS Shur Fellow, and myself, the LWVMI DEI director formed a committee of persons around the state to use a questionnaire developed by LWVMI to review their marketing materials through a DEI lens. This included determining if their material sends a message of inclusion or exclusion? Does this material communicate the importance of a membership that comes from a variety of backgrounds and regions?"

The committee suggested areas for improvement: use gender-neutral pronouns such as *they*; include in electronic and print material representation of the disabled and LGBTQ community if available; and include more photos of people in general.

It is recommended that local leagues consider these suggestions and regularly evaluate their marketing materials, both print and electronic, to promote diversity, equity, and inclusion.

# Legends & Legacies: Flo Rhodes - 50 yrs. LWV

Ann Nicholson asked Flo Rhodes about her 50 year+ LWV membership - here are Flo's words:

I joined the league of Women voters in 1965 when my husband joined the history faculty of what is now the University of Wisconsin -Whitewater. At that time it was making its way from a normal school to one of the schools in the Wisconsin University system. It was a time of rapid expansion in student enrollment, faculty and buildings. Energy and optimism were the key words.

Young families were a big part of the expanding faculty, and a new League of Women Voters chapter had started the year before my husband and I arrived. It was a very energetic group and attracted many newcomers in the next few years. Our first project, as I recall, was an open housing ordinance for Whitewater.

Over the years I would say that our major contribution was in voter services. Wisconsin had initiated same day voter registration, and residence for voting was determined by the district where citizens lived most of the year. That meant students at the university voted at Whitewater, and every year there were hundreds of new voters.

My activities in the chapter were interrupted several times when we lived out of the country, but I always kept my membership. When our family made a permanent move to Grosse Pointe, I automatically joined the League and began working once again on voter services, making sure Your Government Officials was updated after each election. I have very much enjoyed being a member here for the past ten years.

Tom's resignation as our President is a great loss. We owe him a debt of gratitude for his excellent leadership of our League. Tom's energy and commitment to the LWVGP was evident by his enthusiasm and accomplishments. Here are a few that stand out.

- Tom believes passionately in the democratic system and the need for an educated voter, and saw so much untapped potential in LWVGP. His first goal was to make our League more visible and respected in the community. To that end, our league really increased its presence at community events. He organized tables at expos, career nights, etc. and personally worked at most of them. In addition, he also marched in the Pride Parade.
- Tom was very supportive of our Voter Service efforts. He was present at our candidate forums and also at our high school voter registration campaigns.
- Macomb Unit: Tom spent a lot of time with the Macomb Unit before and during his presidency. He helped them get started, attended their meetings and assisted with events. Tom helped them apply for grant money and really did whatever they asked. He was extremely proud to see them graduate to independent League status.
- Tom consistently focused on the mission and goals of LWV, and approached the presidency as a job, sacrificing some of his personal interests at times. Between his energy and enthusiasm and an influx of new members, LWVGP has new visibility and momentum in the community.
- He saw the Coney Island Caper as a potential visibility booster as well as fundraiser, and he and Jan were the main organizers.
- The Making Democracy Work agenda really took off during his tenure and we hosted community information meetings to large groups on regional transit, gerrymandering and Promote the Vote.
- His first year coincided with a leap in membership and he really tried to get those new members busy and involved.
