#### **Proposal 3: New Rights for Michigan Voters**

Last year, our LWVGP members were big supporters of the petition drive for Proposal 3. This was a measure that expanded voting rights by making voting more accessible to more people. Our work helped get it on the ballot and it passed last November. We haven't had a local election since then. LWVGP thinks it is important to remind people about their new rights.

#### **DEI: Diversity, Equity, and Inclusion**

After the January Program planning meeting, a DEI committee was formed to develop recommendations to the board for implementing DEI principles. Committee members Wilhelmina Giblin, Valerie Kindle, and Marge Freundl created a brief orientation for the Board meeting August 14.

The presentation focused on the nature of personal bias. Think about bias as stories or beliefs that we make up about people before we know them. They are often passed on from relatives, friends, the media, etc. Acknowledging our biases can make us feel uncomfortable, but it is the first step toward supporting the need to build mutually beneficial relationships with individuals unlike ourselves. These steps will help to reduce racism, and increase empathy and compassion towards disenfranchised populations. We become advocates and allies with a common goal: to stand up to injustices, voter suppression, and racial and economic inequality.

To remain relevant, our League must eliminate barriers for full participation at League events by members of our community. An example would be to collaborate with the NAACP for a meeting, or host meetings at non-traditional locations. Goals will be set and action plans developed during the year by the board of directors for implementing DEI principles.

Mass shootings in El Paso and Dayton gripped the nation's attention a few short weeks ago. The public outcry for stronger gun laws was loud and clear. Even President Trump joined the chorus. Now the NRA has his ear, and we cannot count on his leadership.

Congress reconvenes after Labor Day. Earlier this year the U.S. House passed a bill calling for universal background checks. Now

is the time to demand that the Senate pass such a bill, as well as a national Red Flag law and a ban on automatic weapons.

Fortunately, Michigan's U.S. Senators are on the right side of this issue. But they are not in the majority. I urge you to contact friends and family in other states asking them to tell their senators to pass sensible gun legislation now.

With the merger of the Ed Fund, and the LWVGP, we have to adopt new bylaws.

The LWVGP Board voted to recommend these bylaws to the membership, for voting on at the September 19 meeting. More information on that meeting is in this Voter newsletter.

Many thanks to Ann Nicholson, who provided rationale in the various sections, Stu Dow who served on the committee, Judy Florian for her always expert proofreading, Wilhelmina Giblin and Sarah Coats who provided valuable input, and the board for their diligence in ensuring we have a document that will carry the LWVGP for at least the next few years without any further changes.

NOTE: The bylaws link was sent to all the membership via email on August 18, which was the required 30 days notice per the current bylaws.

This is also our Kick Off meeting, and we will be voting on the bylaws, introducing the board, and providing the new Voting Rights flyer.
