Preventing Gun Violence: Red Flag Laws Defined

In many high profile shootings, people close to the shooter saw him engage in dangerous behaviors and became concerned about the risk of harming himself or others-- well before the violence occurred. However, in most states it is difficult for families and law enforcement to intervene. An **Extreme Risk Protection Order (better known as ERPO or "Red Flag Law")** makes that possible.

How It Works

An Extreme Risk Protection Order is a court order issued by a judge that temporarily prohibits a person in crisis from possessing or purchasing firearms or ammunition. In many shootings, including interpersonal violence and suicides, family members are the first to notice signs that a loved one may become a danger to themselves or others. Unfortunately, there are very few ways for families to intervene during these periods of crisis. An ERPO is such a tool, allowing household members as well as law enforcement a way to temporarily remove guns and ammunition from the person in crisis and prohibiting them from purchasing new ones for the duration of the order.

Fourteen States Have ERPOs

After the mass shooting last year at Marjory Stoneman Douglas High School in Parkland, even Florida, a state that has long

Michigan is not among the fourteen states with such a tool.

An ERPO cannot only reduce an immediate threat, but it can also create safer circumstances for the individual to seek treatment or to employ other resources to address the underlying causes of dangerous behaviors. Research estimates one life is saved for every 10-20 warrants issued.
