#### **Whirlwind of Candidate Forums**

September and October were very busy months for Voter Services! We had a very ambitious schedule, conducting 5 candidate forums for contested races in the Grosse Pointes and Harper Woods. Here are some numbers: 32 candidates, 27 League volunteers, 365 attendees, 7-1/2 hours of questions...The details are summarized below.

#### Harper Woods Forum-September 23, 2019

All 5 candidates for Harper Woods City Council participated in the forum at the Mary Ellen Stemple University Center. A total of 62 people attended the forum, including League volunteers. This venue was provided free of charge by WCCCD.

#### City of Grosse Pointe Shores-October 7, 2019

Only 1 candidate agreed to participate in this forum. The other candidates were unavailable due to travel/other reasons. League rules require at least 2 individuals participate in the forum. Therefore, this forum was cancelled. This is the first time in the League's recent history that a forum was cancelled.

#### City of Grosse Pointe Park-October 8, 2019

All 5 candidates for Grosse Pointe Park City Council participated in this forum at the Grosse Pointe Park Courtroom. A total of 98 attended the forum, including League volunteers. This venue was provided free of charge by the City of Grosse Pointe Park.

#### City of Grosse Pointe Farms-October 15, 2019

All 10 candidates for Grosse Pointe Farms City Council participated in this forum. There were 6 candidates running for a partial term and 4 candidates running for a full term. A total of 65 attended the forum, including volunteers. The forum was held at Brownell Middle School, which provided audio support/room at a cost to the League.

## Lake Michigan Regional Annual Conference Report

Many of our members may not know that we are, as a Local League, a member in what is know as an ILO (inter league organization). The Lake Michigan Regional League is



made up of the following members: The State Leagues of Michigan, Illinois, Indiana and Wisconsin; and all the local Leagues in those States. Hence, we also are a member.

LWVLMR promotes political responsibility through informed and active participation of citizens in governments and acts on selected governmental issues affecting the Lake Michigan watershed. We support preserving and enhancing the environmental integrity and quality of the Great Lakes-St. Lawrence Ecosystem. We support the attainment and maintenance of high-water quality standards throughout the Great Lakes Basin, with emphasis on water pollution prevention. Water conservation should be a high priority of all governments in the Basin.

On Friday and Saturday, October 25 and 26, I ventured to Lakeside, Michigan for the Annual Meeting of the LWVLMR. This was my fourth time representing our local league. I encourage any of our members with any interest in our environment to join me and/or actively participate in this ILO. It is very informative and rewarding to know how yet another of the League's tentacles is working hard to make a difference. And, as you can imagine, they/we can always use volunteers that want to help.

The main emphasis this year was on PFAs and the Sixth Great Lake, the groundwater of Michigan.

PFAs are really scary. One of the presenters likened it to as dangerous to humankind as Climate Change. Our understanding and identification of the thousands of PFAs is in the infant stage. The subject is way too extensive for me to give a comprehensive report here. I encourage any and all to go online and read about them. They began manufacturing these as far back as the 1940's. One commonly know product with PFAs is Teflon. Nonstick products are

#### **DEI**

The Diversity, Equity and Inclusion (DEI) webinars and TED talks that have been available to you to view have common themes: privilege, power, and the socioeconomics of marginalized individuals, and communities. Communities and organizations that understand these concepts recognize the effects of privilege and power on those without privilege and power; they denounce racism, support full participation of its citizens and members, and share power. That is the goal of the League of Women Voters. Our board of directors is developing an DEI Action Plan for the organization and will be shared with members in the not to distant future.

Privilege is defined as access to or enjoying advantages simply by membership of a particular group or identity; these rights are often unearned and/or underserved. This is different from privileges given to us by our parents or employer. Those with privilege often do not recognize it, or do not admit they are privileged. The privileged have more power than the non-privileged. Researchers suggest that there are dimensions of privilege depending on the circumstance or situation.

Implementing a diverse, equitable and inclusive organization can equalize the playing field so that anyone can enjoy the benefits and responsibilities identified in our organization or community. To equalize the playing field also requires that someone among the privileged stand up and change policies or their behavior; if not, circumstances will not change, i.e. inequities and exclusion of membership in our organization will persist, lack of opportunity in employment, housing, and inequitable treatment by those in power, and other benefits, will continue. It is suggested that we look within ourselves and determine where is our privilege and how does it affect our daily decisions. For example; if you are a privileged individual, have you used a handicapped bathroom stall or parking space for no purpose; this obviously hurts those who have physical impairments. Some communities have instituted policies to even the playing field. For example in San Francisco, it is advertised on buses, and expected that able-bodied individuals will not sit in a seat designated for the elderly or handicapped person; some riders will call you out if you sit in a seat designated for the elderly or handicapped persons.

For the next two weeks, consider thinking about your privilege and how you use it; how can you extend privilege to those without it? Consider sharing your thoughts we me. I would like to post them anonymously in the next Voter, or if you choose I can share your name.
