# Voter Services: Active Fall features forums, and more!

September has been a very busy one for Voter Services! Here is a summary of activities this Fall.

**Candidate Forums**. On Wednesday, September 9, we hosted two virtual candidate forums for 17 Grosse Pointe School Board candidates. On Thursday, September 10, we held a virtual candidate forum for two candidates for District 32A Judge (for Harper Woods). All forums have been loaded onto our <a href="YouTube Channel">YouTube Channel</a>. Thanks to all who helped make these forums a success: Mary Ellen Brayton, Sue Acton, Judy Florian and the Communications Committee.

**Vote411.org.** I admit that I haven't used Vote411 much in the past, but now I'm hooked! Enter your address to find out if you are registered, where to vote, and who is on your ballot. We asked three questions of the School Board and District 32A Judge candidates. Their responses are available in this section, along with responses for U.S. Senator, Michigan Representative, etc. There is also be a printed Voter Guide (see below).

Mailing Absentee Ballots - On September 22, approximately 40 volunteers assisted Derrick Kozicki, Grosse Pointe Farms City Clerk, with mailing approximately 4,500 absentee ballots in the Community Center at the Pier Park. PPE was worn, and volunteers who are not League members (2/3's of them) were given a Membership brochure and an opportunity to buy a Vote411 lawn sign. They were also informed about our recorded forums and upcoming program "Making Your Mail-In Ballot Count!"

**Volunteer Opportunities Abound!** Please consider pitching in with our Postcard effort and Distribution of the printed Voter Guides.

- **Postcards** The ACLU is leading a volunteer opportunity to write postcards to voters in the rising American electorate, encouraging them to turn out and vote in November. After signing up, volunteers will be mailed a package of postcards, with a list of voters to whom postcards will be addressed, and recommended messaging on those postcards. Volunteers should email Mary Ellen Brayton.
- Distribution of election-related printed materials -We have committed to distributing 1000 printed Vote411 Voter Guides and 500 ACLU Know Your Voting

Rights. I will be asking for your help when they arrive later this month! If we can find twenty people to distribute 25 to 50 guides, we will be all set! If you can help, please email me.

**October 6 Program:** Making Your Mail-in Ballot Count! This event will be a virtual Zoom meeting, and we will also record the program and upload to our YouTube Channel.

A panel of three speakers includes

- Derrick Kozicki City Clerk, Grosse Pointe Farms,
- Ms. Soubel Walsh ACLU

Questions posed to them will cover the gamut including the process for obtaining applications for absentee ballots, the process for collecting and counting ballots, what will happen if the results are contested, what happens if someone votes twice (by mail and in person), etc.

Lawn sign sales promote Vote411.org. Please be sure to get YOUR own lawn sign, promoting Vote411, our online voter guide. The state voter guides are being printed, but our own Vote411 effort includes input from the school board candidates and the 32A District Judge candidates.

# Purposeful Actions for Diversity, Equity, and Inclusion

Our league is attempting to create a culture where every member feels included and encouraged to share ideas and perspectives. It should be noted that there is a fine line between inclusion and tokenism. What is the difference? Power.

Leaders of the DEI initiative emphasize that it's not enough to add x number of volunteers, people of color, persons with disabilities, etc. to our organization unless these individuals will be able to influence the work of the league in a meaningful way. Other supporters of this initiative note that DEI must be a choice, not just words.

A recent Detroit Free Press article (9/13/20), emphasized that equity should include opportunities for persons with disabilities to participate in the decision-making process; that a disability may be just one of the many characteristics of an individual. Equity is defined as the quality of being fair and impartial- equity of treatment.

Our organization needs to reach beyond its individual circle of homogeneity and establish relationships with people who do not look like us; we need to move into an uncomfortable space to allow ourselves to engage in conversations that may seem awkward, and acknowledge our implicit bias, and micro-aggressive behaviors. Think about instances where, in spite of positive intentions, your actions and behaviors had negative consequences. What did you learn? What other actions were possible?

If you are in a leadership role or committee chairperson in the league or other organization, reach out to a new member and talk about what is important to them; read articles on DEI that add to your knowledge. Engage in purposeful conversations. Our behaviors today, positive or negative, are a product of our past and current experiences. We can make a conscious decision to change them for a better society. The choice is ours to make.

# **Voting Challenges for Those with Disabilities**

The DEI committee had a recent presentation from Dessa Cosma, Executive Director, Detroit Disability Power regarding issues and concerns for voters with disabilities. They received a grant to address common issues encountered by people with disabilities to document the many stories of continued problems with full access to voting sites and issues casting ballots and other environmental barriers that influence voting.

In addition to their efforts to make the voting process more accessible, DDP is working to ensure that people with disabilities get out and vote. Dessa stated, "We are reaching out to 100,000 voters in Detroit and Highland Park via mail, phone, and/or text message about the importance of voting this November. It is likely that about 20% of those to be contacted are people with disabilities. Even for the other 80%, the information we are sharing is a useful reminder to vote. For those that do share their disability status with us, we will continue to engage them after the election about the issues we organize around, asking them questions about what needs they have related to accessible housing, accessible transportation, and other issues."

## **News from the Treasurer**

At the September 15 LWVGP Board Meeting, our Board approved moving the funds we've set aside for special projects and emergency needs from six separate Certificates of Deposit (CDs) to the Vanguard Total Bond Market Index Fund (VBTLX). The annual yield is 2.84% versus the .35%-.4% our CDs have been earning. Check-writing is available but requires a minimum of \$250; our Flagstar Bank account can handle costs below that amount, especially since the CD funds are for unexpected or special events.

On a scale of 1 to 5 with 1 being a low risk, this bond fund is rated 2. Vanguard's expense fees are the lowest in the industry, with an annual expense fee of .05%.

The advantage of using the bond fund is that the money can be in one central account, earning a higher interest rate. We won't have to constantly monitor maturity dates. And we can use the funds as we need to with the check-writing ability Vanguard provides at no cost. This decision will greatly simplify the management of these investments.

The Board will consider some options for using these funds in the future. Examples can include, but are not limited to, a high school scholarship for students wishing to pursue a degree in political science, supporting LWVMI in their advocacy appeals and legal actions to expand voting rights.

#### **About Your Dues**

Some questions have come up recently about the cost to join our league. For an individual, our annual membership is \$60 per year. For a family of 2 or more, our annual membership is \$90 per year.

It's important that League members understand the breakdown of these dues. Included in that amount are the dues our league pays to our national and state leagues. Our league retains only \$5 of an individual's membership and \$7.50 of a family's membership.

Our league uses the dues you pay to conduct local candidate forums, maintain our league's website, and publish a monthly newsletter, among other activities and operation costs.

The rest of our dues goes to our state and national leagues to pay for a wide array of efforts, to include but not limited to, legal actions such as the lawsuits filed here in Michigan for greater access to voting rights and to end gerrymandering, information on ballot proposals and actions taken or under consideration by our state and federal representatives, advocacy for better education and stronger environmental legislation.

We believe the nonpartisan services we provide to our communities along with the efforts our state and national leagues provide to us all are well worth the dues our membership pays.

Hopefully, you do too and will share the good work the League of Women Voters has provided with your family, friends and neighbors.
