President's Message

Despite the challenges of a global pandemic, Americans voted in record numbers on November 3rd. To quote Michigan Secretary of State Jocelyn Benson "excellent work by 83 county clerks, over 1,500 city and township clerks, tens of thousands of poll workers who staffed polling places and counted ballots from dawn to dusk, and a record-breaking 5.5 million voters who exercised their fundamental right to vote even in the midst of a pandemic, including over 28,000 who registered and voted on Election Day."

We had many League members serve as poll workers as well as absentee ballot counters in our community. I am so proud of our many members who worked the polls and also rose to the challenge to educate voters during this election season. Our program, Making Your Mail in Ballot Count was a great success, with 40 people in attendance. Special thanks to Mary Ellen Brayton for developing this program. The

video recording was viewed by over 60 people on our [YouTube Channel](#). Our Vote411 video, developed by Mary Zahler, was also helpful to voters who could view their ballot on-line before voting. We also educated voters in our community on the location of drop boxes for their absentee ballots. The Grosse Pointe News printed an article, with photographs, and it was also posted on our Facebook Page, reaching over 4,000 people! Voter education is a centerpiece of our League and we rose to the occasion!

Several League members volunteered for the LWVMI Post-Election Observer Corps for the Wayne County Board of Canvassers. The Board "canvasses" elections by carefully reviewing and authenticating various forms and certificates completed to document the vote cast at the polls. The Wayne County group, chaired by Paula Bowman, Northwest Wayne County League, viewed via Zoom or attended in-person sessions to review how the Board of Canvassers works. For me, it was a very interesting process and educated us all on what happens after Election Day! Thanks to the following members who volunteered for the Observer Corps: Sue Acton, Mary Ellen Brayton, Lauri Kingsbury, Laura Larson, Judy Masserang, Joan Morris, Lambro Niforos, and Mary Zahler.

I am pleased to announce that Ann Nicholson has graciously agreed to serve as our League's Historian. Ann has handled our archives in past years. If you have any documents or other items related to our League History, please contact Ann.

The Diversity, Equity and Inclusion Committee (DEI) sponsored a program on October 22, *Weaving the Fabric of Diversity*. It was an excellent program attended by about 35 people. The recording of this program is available on our [YouTube Channel](#).

Our Program Committee, Valerie Kindle, Carol Todd and Denise Allen, presented a great virtual program, *Some of Life's Challenges in the Coronavirus Community* on November 11. Making Democracy Work (MDW) Grant Update

Our League was awarded a \$400 Making Democracy Work Grant through the LWVMI, funded by LWVUS. This grant focused on Election Protection efforts for the August 2020 Primary and November 2020 elections. Election Protection and Voting Rights are the heart of the League of Women Voters. For 100 years, we have been encouraging informed and active participation in government. We accomplish these goals in collaboration with other organizations. We work for diversity, equity and inclusion to extend traditional and important LWV Voter Services to reach more voters and to gain more voters in historically disenfranchised communities.

We are fortunate the LWVMI applied for and received these grant funds to assist local leagues in their Election Protection efforts.

The goals of the grant were as follows:

- Education for voter protection to monitor implementation of Proposal 3 of 2018
- Education for election protection through engagement with county and local clerks
- Increased visibility of Vote411, expanding media and social media engagement

The LWVGP implemented the following to accomplish these goals.

- Engaged local clerks with election protection information; assisted the GPFarms clerk with mailing absentee ballots for both the August Primary and November General elections; worked with clerks to secure poll workers for elections.
- Promoted Vote411 on Facebook, Webpage, and various media articles in the GP News, GP Patch, and Grosse Pointe Times.
- Developed a Vote411 video to educate voters on how to review their ballots prior to Election Day; promoted Vote411 in GP Public Library newsletter.
- Sponsored a program, *Making Your Mail in Ballot Count*, to emphasize the proper procedures for absentee ballots; promoted drop boxes in our local jurisdictions to increase awareness of their locations.
- Conducted lawn sign fundraiser to promote Vote411.org.
- With the ACLU, addressed and mailed 2500 postcards to Michigan voters in high risk and disenfranchised areas.

We are pleased with the leadership and support provided by Christina Schlitt, LWVMI President, during all phases of the MDW grant and the opportunity to participate in this initiative.

Voter Services Report

Grosse Pointe Park City Council - We ran three interview sessions to fill a vacancy for the Grosse Pointe Park City Council. Thanks to our Moderator Sue Acton and Time Keeper Steve Trowbridge.

Election Workers - Thank you to LWVGP members who worked the polls, were LWV observers at the Wayne County Board of Canvassers, posted important election information on social media, and distributed Know Your Voting Rights and Voter Guides.

Your Government Officials- Voter Services will be updating the League's popular "Your Government Officials" brochure. This means that we will be contacting national and state offices plus every Grosse Pointe and Harper Woods government, Grosse Pointe Schools and two library systems to insure that our contact information is current.
