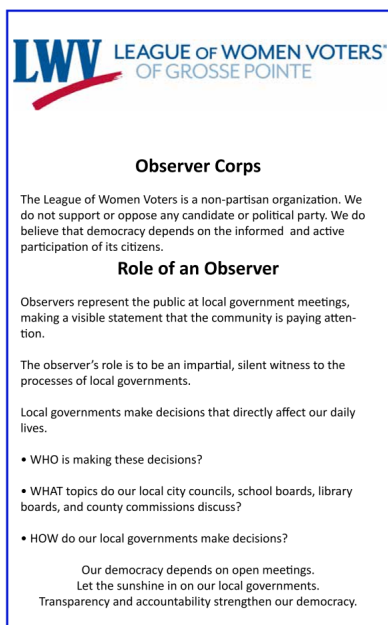

Program for October: Mapping Michigan's Future

The Kickoff meeting is October 27, 7:00 p.m. (location TBD)

The focus will be on the [MICRC](#) and the mapping process for the new congressional districts and new state senate and state representative districts. The lead speaker will be longtime demographer Kurt Metzger,

who will set the stage by talking about the population shifts in Michigan, including the 2020 Census. He will be followed by a commissioner from the MICRC who will present the proposed maps and describe some of the thinking underlying those decisions. This meeting is timely, as it is held one day before the scheduled public hearing about the proposed maps at the TCF Center in Detroit. This gives Grosse Pointe and Harper Woods residents the opportunity to hear and review the maps and then follow up the next day with formal testimony before the commissioners.

There will be lots of time for a Q&A, so come prepared with your questions.
