#### Promote the Vote has Impact on November 2019 election

Preliminary information from the Michigan Secretary of State shows that Michigan voters took advantage of the new Promote the Vote constitutional amendment. Within 14 days of the November 5 election, 2,022 Michigan voters registered to vote and voted, with over 1,131 registering and voting on Election Day!

One-third of those registering on Election Day were 18-21 years old and more than half were 30 years old or younger. In addition, 314 people aged 60 or older registered and voted during the 14-day timeframe.

With additional education and awareness about the new law, these numbers should only increase for the 2020 election.

#### March 10, 2020 Presidential Primary

The 2020 Presidential Primary is designated as a "closed primary", which means those participating in the election must choose a Democratic, Republican or no-Presidential Primary (local issues only where applicable) ballot when voting absentee or at the polls on Election Day. While a voter must select a specific party ballot, there is no political party registration in Michigan's voter registration system.

The Presidential Primary is a reimbursable election. This means counties will be reimbursed for the cost of producing ballots and other costs directly associated with conducting the election.

#### On-line Voter Registration System Goes Live

The Secretary of State announced in November 2019, that the Online Voter Registration website is live and available. It can be found at www.Michigan.gov/Vote by selecting the "Register to Vote" option located

on the left panel of the page. The tool can also be reached directly by going to <a href="www.Michigan.gov/VoterRegistration">www.Michigan.gov/VoterRegistration</a>. Residents across the state can take advantage of this convenient way of registering to vote. Current voters can easily change their address using this website. Registering to vote has never been easier and can be accomplished by navigating five easy screens:

- Welcome screen
- Qualifications
- · Personal Information
- Address
- Congratulations screen with receipt option

To use this convenient website, visitors must currently have a Michigan Driver's License or Personal Identification Card and qualify to vote in the state of Michigan (i.e. Citizen, age, residency).

### **New Absentee Ballot Envelopes**

The Bureau of Elections Forms Committee, comprised of local and county clerks, is working with the Center for Civic Design to redesign the absent voter ballot envelopes. The previous design was encountering more and more issues with the United States Postal Service (USPS) and sometimes the misdirection of ballots. The primary purpose of this redesign was to prevent those issues and to prevent the disenfranchisement of voters. The new design has a more modern look and feel including a few small details that should have big impacts on voters properly returning their ballot and process efficiencies. This includes the following:

- The voter's signature on the backside of the envelope, the side they
  will see when sealing the envelope. November pilot jurisdictions
  noted a significant decrease in unsigned envelopes.
- The ballot label will be on the backside of the envelope, allowing staff issuing ballots and election inspectors processing ballots on Election Day to view the ballot number without flipping over the envelope.
- Clear language (when not prescribed by law) to explain delivery options.
- A smaller size, which has been requested by USPS as the former size was the maximum for first class mail. This allows for better automation and easier handling by carriers.

# Legends & Legacies: JoAnn Kelly, Lifetime Member

JoAnn Kelly knew about the League long before she was old enough to vote. Her Aunt Jean had a cadre of interesting friends who advocated for important changes through the League of Women Voters, and young JoAnn was fascinated by their activities.

When she came to Detroit with her husband and young family in 1968 she decided to join the Detroit League, a dynamic force in the city with an office downtown. The structure of a national, state and local organization attracted her. Her first League job was organizing a candidate forum. One of the candidates was John Kelley, a familiar name in Michigan politics for decades after.

When she and her husband, Jim, moved to Grosse Pointe a few years later she transferred her membership to the Grosse Pointe League. She served as Membership Vice President, President, and has been a contributing member to many committees. As Program Vice President she organized the study on Immigration, and started what became a series of Town Hall meetings on local issues. She is a skilled moderator for panels and candidate forums.

After retirement she and Jim began to spend the winter months in Florida, where she has become interested in the Sarasota League. The Florida State League is very active and JoAnn works on issues of gun violence both there and on the Michigan League Advocacy Committee.

Like her Aunt Jean, JoAnn has met many interesting women and found a venue for advocating on issues important to her through her League work. The Grosse Pointe League is lucky to have such an articulate, thoughtful life member.
