

Virtual Candidate Forum: a First for Our League

Ordinarily LWVGP would host a live Candidate Forum for the August 4 primary election because there are two Democrats (Taylor Harrell and Joe Tate) and one Republican (Mayra Rodriguez) running for the Michigan House of Representatives District 2 seat (District 2 covers Grosse Pointe City, Farms, and Park, as well as northeast Detroit).

The form must be signed and dated, and then returned to your City Clerk.

- If you return your application by the Friday before the election, your ballot will be mailed to you.
- If you bring your application in on the Monday before the election, you must vote at the city building.

Online Voter Registration for High School Seniors

Ordinarily the LWVGP visits our three high schools (Grosse Pointe North, Grosse Pointe South, and Harper Woods) to register seniors who will be 18 by Election Day.

Because these events weren't possible this year, we used a two-pronged approach to reach high school seniors.

- One was a flyer that was distributed to all students through their high school media. This flyer pointed out the ways that students could register (online and in person) and why their votes are important (e.g., only 1/3 to 1/2 of adults 18-24 voted in recent elections, the lowest of any age group).
- Voter Services also created a [Power Point](#) presentation especially for young voters. This presentation was sent to the high school principals.

LWVGP Working with Local City Clerks

Workers in the November Election will be more in demand than ever because of what is expected to be a record number of absentee ballots. In addition, many past workers who are seniors may opt out of working because of COVID19 health concerns. Voter Services will be contacting local City Clerks to help ascertain their needs for Election Day volunteers, raise awareness and help recruit workers.

Why Does the League Need to be Diverse, Equitable, and Inclusive?

I am sure that most of you have seen the issue of racism rear its ugly head once again: another black man dead at the hands of a white police officer, white men shooting and killing an unarmed black man jogging in a neighborhood; and a black man falsely accused of harassment by a white woman in NY Central Park when he asked her to put her dog on a leash. We have seen increasing incidents in the past several years involving harassment or death of black people at the hands of white

people. The latest death happened in the Minneapolis police department, which is majority white. Would this incident have happened if the department were diverse, where different races, perspectives, ideas and friendships could flourish? Would frivolous phone calls to the police by white people about black people occur if more white people formed friendships with black people? We have more similarities than differences.

Black persons interviewed on television recently described their frustration with being devalued, marginalized and discriminated against by white people. Black parents speak of the burden of talking to their children about what to do if approached by a police officer; of having the realistic fear that their own black children would be harmed or killed by the police. These are conversations that white families don't expect to have with their children. White people don't have to carry this burden.

In many parts of our nation, there is one justice system for whites and another for blacks. According to a recent New York Times article, "for most white Americans, interactions with the police happen rarely, and they're often respectful or even friendly. In many black communities, and especially for black men- the situation is entirely different. Black males are incarcerated more frequently than whites. ...and suffer economic and psychological damage after they leave prison."

There is an unfounded fear today of black men, dating back to stereotypes of black people created by white slave owners. Black men live in fear of the fear that whites have about them.

We must have the difficult conversations about our biases, prejudices and fears and work toward freeing ourselves of this cancer that is eating the fabric of our society. Our nation will stand together, or fall together. The choice is ours to make. Henry David Thoreau once said: "It is never too late to give up your prejudices." Martin Luther King Jr. has said, "Injustice anywhere is a threat to justice everywhere."

Our League can help to rid our nation of its biases and injustices by reaching out to others unlike ourselves and establishing new friendships; joining the fight for the rights and privileges that all people in our community deserve, regardless of race, ethnicity, or culture; and forming a more diverse and inclusive organization.

The 2020 Census is still in process!

Traditionally a challenge for some, it has been more difficult for many this year as the usual means to approach residents door-to-door has been impeded by pandemic restrictions.

Additionally, there are some US residents who fear repercussions if the government has their information. The US Census Bureau assures us that it is "bound by law to protect your answers and keep them strictly confidential. In fact, every employee takes an oath to protect your personal information for life".

As of June 9, less than $\frac{2}{3}$ of US households have completed the Census.

- Michigan has a 67% response rate, with 53% completed using the internet.
- In Wayne County, 62% of residents have been counted, with less than 48% by internet.
- Detroit has less than half of its households counted, with less than a quarter being captured online.
- For the Grosse Pointes and Harper Woods, response rates range from 72% (HW) to 85% (GPW and GPF).

2020 Census field operations have begun in phased restarts as pandemic restrictions are lifted; Detroit restarted the first week of June.

Here are some important dates for the Census:

April 1: This is Census Day, a key reference date but not a deadline.

Mid-April: The Census Bureau mailed paper questionnaires to homes that had not yet responded online or by phone.

July 1 - September 3: Census takers will work with administrators at colleges, senior centers, prisons, and other facilities that house large groups of people to make sure everyone is counted.

August 11 - October 31: Census takers will visit households that haven't responded to the 2020 Census to make sure everyone is counted.

December: The Census Bureau will deliver apportionment counts to the President and Congress as required by law.

Hundreds of thousands of businesses, organizations, and individuals nationwide are voluntarily supporting a complete and accurate count in the 2020 Census.

In Michigan, volunteers are being trained to staff phone banks to call citizens; this can be done from your own home, with the recipient only seeing the local phone bank number on their caller ID. Michigan maintains a state ["Be Counted" website](#) with more information on how to volunteer and be trained.
