### **President's Message**

In this last message to you as your President, my reflections of this past year are both excitement with our many accomplishments, but also a sense of anxiety about the threats to our democracy.

First, our accomplishments! Our 71st Annual Meeting on May 11, 2021 featured an excellent presentation by Cynthia Sohn and Clare Pfeiffer on the upgrades to the Edsel and Eleanor Ford House. If you haven't had a chance to visit the new facilities, I encourage you to do so! Our League provided the opportunity for 12 members to attend the 2021 LWVMI Convention: Defending Democracy. Voting delegates included Sue Acton, Denise Allen, Marge Freundl, Cathy McAdam, Mary Zahler and myself. Non-voting attendees included Connie Frey, Mary Jo Johnson, Lauri Kingsbury, Laura Larson, Carol Lufburrow and Judy Masserang. Vicki Granger served as a LWVMI voting delegate. The Estate of George McMullen sent, at his bequest, a check in the amount of \$1,500. As stated in the letter, this was a donation to the league, "an organization that he loved." We are extremely grateful for this gift and will use it to continue

George's legacy as we review options to reinstitute an Observer Corps in his memory.

The work of the Michigan Independent Citizens Redistricting Commission (MICRC) continues, with two public hearings conducted in Detroit on June 15 and June 17. Three of our members, Marge Freundl, Jennifer Goossen and Laura Larson, served as volunteers for these hearings. Your Communities of Interest (COI) team (Lauri Kingsbury, Carol Lufburrow and Cathy McAdam) continue to work with local organizations to emphasize the importance of mapping COI's to influence legislators.

Now for my anxiety. Between January 1 and May 14, 2021, at least 14 states have enacted 22 new laws that restrict access to the vote. At least 61 bills with restrictive provisions are moving through 18 state legislatures. The Michigan legislature has jumped on the bandwagon by introducing 39 voter suppression bills. On June 16, the Michigan Senate voted to pass three bills expanding ID requirements for voters before their ballots can be counted. The bills remove the option to vote by affidavit if a voter does not have a suitable ID and require voters to submit identifying information for an absentee ballot application.

The LWVMI has opposed these proposed bills. "In 2018, Michigan voters overwhelmingly voted to make voting more convenient, not more restrictive," said Christina Schlitt, president of the League of Women Voters of Michigan. "These anti-voter bills will lead to voter disenfranchisement and make it more difficult for voters to exercise their rights. Michigan's elections are fair and secure; there is no need for this legislation."

It is up to each of us, as members, to contact our State Legislators and encourage them to vote against these bills. The very foundation of our democracy is at stake. A special thanks to the 2020-21 Board of Directors and Off-Board members for their support during my leadership. It has been an honor and privilege to serve as your President and to work with such a talented and committed group of individuals. The League will be in excellent hands as I turn the gavel over to Sue Acton as your incoming President. I will continue as an off-board member handling publicity and as Co-Editor of The Voter. I will also serve as the Vice President for Voter Services for the LWVMI for the next 2 years. Wishing you a happy summer as we begin to venture out again to some sense of normalcy.

## **League of Women Voters of Michigan Voices Strong Opposition to Passing of Anti-Voter Bills**

LANSING – The League of Women Voters of Michigan condemned the Michigan Senate's passage of bills to make voting more difficult.

"In 2018, Michigan voters overwhelmingly voted to make voting more convenient, not more restrictive," said Christina Schlitt, president of the League of Women Voters of Michigan. "These anti-voter bills will lead to voter disenfranchisement and make it more difficult for voters to exercise their rights. Michigan's elections are fair and secure; there is no need for this legislation."

The Michigan Senate voted to pass three bills on June 16, expanding ID requirements for voters before their ballots can be counted. The bills remove the option to vote by affidavit if a voter does not have a suitable ID and require voters to submit identifying information for an absentee ballot application.

"These bills directly and negatively affect seniors, people with disabilities, people with limited incomes and young people, who all have difficulty obtaining the type of ID that is sometimes required to vote," Schlitt said. "Michigan has voter ID laws on the books, and our system for affidavit options has worked for decades. These new restrictions are unnecessary."
