Promote the Vote 2022 (PTV2022)

PTV2022 is a ballot initiative sponsored by Promote the Vote and **14 partners** (including LWVMI) to change the Michigan Constitution. This ballot proposal will enshrine in our constitution some of the things that make our elections secure and fair already, especially some rights that some current voter suppression bills and petitions are trying to take away this year.

Across the state, PromoteTheVote and its partners need to get 425,000+ signatures by mid-July to put a Michigan Constitutional Amendment on the ballot this November. This is a huge undertaking and LWVGP is committed to gathering at least 1,000 signatures - that's 100 petitions. If everyone in LWVGP circulated just **one** petition, we would reach our goal!

Voter Services: Student Voter Registration, Candidate Forums

Student Voter Registration is always an exciting event as we register students who are at least 17 $\frac{1}{2}$ years old. This will be the first time since 2019 that we have been able to do these events in person.

We will hold an in-person Student Voter Registration event at Grosse Pointe North High School on Friday, April 29, 7:45 a.m.-12:20 p.m.. Voter Services Director Mary Garlough is handling this event. We still need volunteers, so please contact Mary if you're available.

We will not conduct voter registration activities at Grosse Pointe South and Harper Woods. Both schools have signed up for the Secretary of State's MI Vote Matters High School Registration Challenge and will be doing their own events this year.

Candidate Forums for the Grosse Pointe and Harper Woods School Boards, along with our State Representatives, will be conducted this year. Forums won't be scheduled until we determine how many candidates have applied to run for office: the deadline to apply is April 19. Our LWVGP forums for these elections will take place in June for the August Primary, and in September for the November General Election. We eagerly anticipate that our forums will be in person. We will need moderators, greeters, question gatherers and question sorters. Please contact Mary Zahler or Mary Garlough if you would like to help with the forums.

TEDTalk Video recommended by the DEI Committee

This video, *The Urgency of Intersectionality*, suggests that we boldly look at the reality of race and gender bias and understand how the two can combine to create even more harm. Kimberlé Crenshaw, Professor of Law and UCLA Law School, uses the term *intersectionality* to describe this phenomenon; If we can't see the problem, we can't fix the problem-need action and transformation. **Here is a link** to the TEDTalk.
