We will do more to amplify our voice in two big ways this month.

Library Recommendation Headed to Convention

At its March 11 meeting, the LWVMI Board of Directors concurred with our revision to the library position, approved at our January 11 Program Planning Meeting.

The next step is to present this position during the Plenary sessions at the LWVMI Convention, May 19-21. A workgroup of the following members has completed the formal process: Sue Acton, Judy Florian, Marge Freundl, Vicki Granger, Lauri Kingsbury, and Lynne Pierce.

We have submitted the required documents to the LWVMI Co-Presidents, Paula Bowman and Christina Schlitt, as well as local League Presidents, for their review prior to Convention and possible adoption statewide. The amplified voices of the League are needed for this issue, and we are pleased to be on the leading edge, fighting back on the book banning political interference making headlines, especially those from well-funded outside groups.

Action Alerts Make a Difference

We want to amplify our individual voices even more at the state level. <u>LWVMI</u> recently sent out Action Alerts in support of Michigan bills: the Elliott-Larsen Civil Rights Act, National Popular Vote, and Firearms Safety. Our Legislature has been very busy. An Action Alert is a notice from LWVMI to all members that action is needed on state legislation. You are encouraged to respond to Action Alerts if you agree with the legislation. If everyone lets their legislator know of their support, one voice becomes almost 3,000 voices.

Local League Legislative Interviews
