- 2. You are 18 years of age.
- You are a resident of the State of Michigan and your city, township or village for at least 30 days before Election Day.
- 4. You are not serving a sentence in jail or prison.

# **Absentee Voting**

You do not need to have a reason to vote absentee. You can apply using one of the following methods:

- Online Registered voters can request an absentee ballot online from michigan.gov/vote
- Call your city clerk and ask that an application be mailed to you
- Download an application to return by mail or in person to your local city clerk
- In person at your local city clerk's office

Absentee ballots have deadlines. Find details at michigan.gov/vote.

# **Early Voting**

Michigan voters have the right to cast a ballot early and in person at an early voting site before Election Day.

Early voting will be available beginning with the presidential primary in 2024 and every statewide and federal election thereafter. Contact your local Clerk for information on early voting sites, dates and hours.

# Voting Hours on Election Day 7:00 A.M. to 8:00 P.M.

Photo identification OR affidavit is required at the polls.
