# **President's Message**

Greetings Folks,

I wish I could tell you all to have a great summer and see you in the fall. But this year, with a crucial election coming up, we won't be able to take a break from League duties. There is too much at stake! Between now and November we will be doubling down on our efforts to register, engage, and inform voters.

The League, at local, state, and national levels, will be working hard to protect your right to vote. It is time to sound the alarm: Our Democracy is at stake! Our speakers (Jeff Timmer and Mark Brewer) at our May event really honed in on what it means to continue to have a strong democracy. They stated that while the majority of citizens are "pro-democracy," our democracy is only strong when the minority accepts the results. They warned that we will be dealing with the aftermath of this election for a long time.

The League will be at the forefront of preserving our democracy! What kinds of things can we expect? For one, we know there will be mass challenges of voter laws and registrations. In Michigan, a battleground state, the Secretary of State has already been sued in federal court by a group alleging the voter rolls are out of date. The Secretary of State insists she is following the law. The LWVMI has filed a motion to intervene in this case. To stay up to date on LWVMI's advocacy actions, click <a href="here">here</a>.

There are lawsuits challenging voting practices throughout the nation. The LWVUS has intervened in many of these challenges. Click <a href="here">here</a> for the LWVUS Legal Center to find out more about their involvement in these cases.

The experts anticipate there will be massive attempts to use Artificial Intelligence (AI) to disrupt our election process. This will include disinformation and misinformation on social media platforms. If you see this, don't repeat it and let others know it is not true.

We anticipate there may be civil disruption at voting locations, absentee ballot counting boards and Board of Canvasser locations. (Remember what happened in Detroit four years ago?) In many places, city clerks are under attack.

What more can we do? Show up and observe! Participate as election workers, observe at absentee ballot counting locations and act as observers at the Board of Canvassers. Our presence at the polls helps reassure voters that our elections run smoothly and are fair and secure.

Stick up for democracy We must continue to say it loud and clear. The League's integrity as a nonpartisan group puts us in the unique position to stand up and speak out for democracy. Collectively, we do a phenomenal job doing just that! Keep up the good work!

# **Town Hall Presentations on New Voting Rights**

LWVGP conducted two town halls on Michigander's new voting rights, based on the passage of Proposal 2 of 2022. They were conducted at the GP Mens' Club on May 14th and American House on May 22nd. The third town hall will be held at The Helm, Grosse Pointe Farms, on Thursday, May 30th. These are educational meetings to inform voters in our communities about our new voting rights, just in time for the Primary Election on August 6th and General Election on November 5. Lynne Pierce and Judy Florian conducted the presentations

and the meetings were very well received. As an added bonus, LWVMI will reimburse us \$500 for providing this information to our voters.

### **Board Approves Local Advocacy Position on Senior Services**

An advocacy study group submitted its paper and a proposed position statement on senior services to the LWVGP Board on Tuesday, May 21, 2024. The proposed position statement reads:

The significant increase in the count of seniors projected over the next fifteen years in the Grosse Pointes and Harper Woods communities requires community-wide financial support from local governments and nonprofit organizations to ensure seniors have access to necessary resources and support. Essential services in public health, specifically senior services, should be integral components of each community's infrastructure to promote and protect the health and well-being of its older population.

This proposed position is based on extensive research from the following: medical and public health sources, demographic projections, and legislative and government agencies at local, state, and national levels.

The Board approved this position statement. It is now up to the members to vote. Our LWVGP Bylaws require that members receive the study itself and the proposed position statement 30 days prior to voting on it. The study and proposed position will be sent to all members in June. A special membership meeting will be scheduled in July. Questions regarding this study and the approved positions can be posed at the Annual Meeting on June 18.

If the members vote to formally adopt the position, our local League will be able to take public action based on this position.

### **Advocacy News At the State Level**

LWVMI supports the passage of two bills in the Michigan Senate that will require the Legislature and the Governor's Office to comply with the Freedom of Information Act. These bills are SB 669 and SB 670.

Michigan's new gun safety laws took effect on February 13, 2024. They include:

- universal background checks
- safe storage of firearms in homes with children
- extreme risk protection orders, sometimes called "red flag" orders
- protections for domestic violence survivors

# **Board Approves New DEI Policy**

At its May 21st meeting, the LWVGP Board approved adoption of the LWVMI Diversity, Equity, and Inclusion (DEI) policy, which reads as follows:

Discrimination or harassment of any kind will not be accepted within the League, including, but not limited to race, socio-economic status, age, disability, religion, sexual orientation, national origin, gender identity, or marital status. The League is committed to fostering, cultivating, and preserving a culture of diversity, equity, inclusion, access, and belonging for all people. The League is an organization that respects and values the richness of our community and our members. The collective sum of our individual differences and life experiences represents not only our culture, but our reputation and the organization's mission and achievements as well.

**DEI updates May 2024** 

- The Michigan DEI committee will be sending out a DEI survey this summer. The LWVMI Board of Directors is gathering this information about its members to look at state wide representation of those who are doing outreach to voters and how well they represent their communities.
- LWVUS has updated the DEI policy, now on our web page. Our League adopted the approved language of the LWVMI, using the term "disability" rather than "ability status" (see above). This aligns with the Association of People with Disabilities, a widely recognized voter advocacy organization.
- Our local DEI committee is working on a high school video project to promote the importance of voting with youth. Watch for more details in the fall!

## **Redistricting Commission Redrawing MI Senate Maps**

As part of their December 2023 ruling, the Federal District Court found the Senate maps for Districts 1, 3, 6, 8, 10, and 11 unconstitutional under the 14th Amendment of the U.S. Constitution because race was too big a factor when the MICRC drew the maps for those districts.

The unconstitutional districts include southern parts of Macomb and Oakland Counties as well as Detroit and much of Wayne County, including the Grosse Pointes and Harper Woods. Adjoining districts may also be impacted.

Residents of affected districts are urged to tell the Commission which of the Senate Draft Proposed Maps they prefer during the Public Hearings on June 11-13. Public Comments can be made in person or virtually. Those wishing to comment virtually must sign up in advance on the MICRC website, <a href="https://www.Michigan.gov/MICRC">www.Michigan.gov/MICRC</a>
