President's Message

It is always energizing and informative to attend the national convention and this year was no exception! Over 1400 League members across the country attended

in person or virtually. The convention was held in Washington, DC and also allowed us an opportunity to lobby our representatives.

The agenda was jam-packed with important items to discuss. As always, there was spirited debate, but we left the convention with our overall theme of "the League speaks with One Voice". We voted to reaffirm our primary focus on the Campaign for Making Democracy Work. This includes redistricting reform, voting rights protection, improving elections, money in politics and direct election of the president.

All our current positions were retained, and we voted to concur with resolutions to support Washington, DC statehood, Ethics in Government, Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW), Fair and Humane Immigration reform, support of public libraries and reproductive rights. In addition, we approved a new accelerated study on the federal judiciary (I will probably end up assisting on this study once the election is over).

I was very excited to hear that the LWVUS has a new partnership with the Girl Scouts of America! This will hopefully be a pipeline for new, younger members. These types of coalitions will help us grow and improve our organization to stay viable in the future. Speaking of younger members, there were many at our convention. They are engaged and spoke up about the things they care about. Part of their message to the greater group is that they want to belong, not just fit in. This means we must be open to change! Not easy for us old folks!

We were also introduced to our new president, Dianna Wynn, and our new CEO, Celina Stewart. I was very impressed with both women and feel confident our League is in good hands going forward. They told us the League is the most trusted group in politics! What an honor! This is because we have dedicated ourselves to nonpartisanship since the beginning and people listen to what we have to say.

Our book banning workshop was a huge success! Sue Acton and I gave the presentation, with the help of Dawn Drozd, Judy Florian, Julianne Phillips, Carol Luftburrow, Lauri Kingsbury, and Vicki Granger (and our IT guy, Ray Andary). As anticipated, it was well attended – over 150 people. Across the nation, Leagues are tackling this issue. The feedback was very positive, and attendees appreciated the step-by-step process we provided them. A special thanks to

Carol and Lauri, who purchased almost 100 banned books to give away at the session. We also had book bags and pins for the attendees, which were very popular! You can view the presentation **here**.

LWVUS Convention Highlights

LWVGP was well represented at the LWVUS Convention in Washington, DC June 26-30. Lynne Pierce, President and Sue Acton, Past President, presented an excellent workshop on *Book Banning: How to Fight Against it* (see related article below). There were many positive comments from attendees throughout the Convention.

Another highlight was lobby day, where convention attendees visited Capitol Hill to meet with their elected representatives. Although Congress was not in session during that time, there were several Michigan Leagues that were able to visit their representatives. The Michigan Convention delegation visited with Senator Gary Peters' aide, Eli Schooly, who was very knowledgeable about Senator Peters' stance on many issues. In addition, the Grosse Pointe contingent of Lynne Pierce, Dawn Drozd, Sue Acton, Julianne Phillips, Judy Florian and Sara Weertz (Detroit League) visited with Representative Shri Thanedar's aide, Valeria Postigo, who was very receptive to our comments related to the Congressman's support of the John Lewis Voting Rights Act. She also explained his priorities on mental health (addressing the epidemics of suicide and drug overdose) and his continuous effort to provide small business resources in our community.

Success at the LWVUS Convention

One hundred fifty-eight delegates - 90 in-person, 68 via Zoom - attended our workshop: *Book Banning: How to Fight It* on the first day of LWV's National Convention. They left energized and equipped with the tools to fight back against book challenges and bans.

We approved our public library and school libraries advocacy positions in 2022. In 2023, LWVGP took our public library to the state convention where it was unanimously approved as a state-wide League position. This year, LWVUS invited us to give a workshop on the national level.

President Lynne Pierce discussed the scope of the problem, the organized groups orchestrating local book bans and their tactics. Past President Sue Acton, who led the effort to get the advocacy positions accepted locally, illustrated the study and approval process. She highlighted the work of our DEI Committee and Observer Corps, who did so much to bring this to our attention in 2022. Lynne wrapped up the 30-minute presentation with ideas and resources for advocating on local and state levels.

Lynne and Sue fielded questions and comments from the in-person delegates. Lauri Kingsbury, (a virtual delegate), answered chat questions from the virtual delegates on Zoom.

Several giveaway items—book bags and 96 books that were challenged or banned in local libraries during the past 10 years—were provided to attendees, along with bookmarks, buttons and various resources from the American Library Association (ALA). An 8-year-old girl attended the workshop with her mother and was very excited to receive copies of books! We collected \$215 in donations. One generous delegate put \$40 in the donation box!

Along with Lynne and Sue, this presentation was a collaborative effort by other members, including Judy Florian, Marge Freundl, Vicki Granger, Carol Lufburrow, Lauri Kingsbury, Julianne Phillips, and Annie Spence, who developed topics and put together a dynamite slide presentation.

The Maine League is working on a state position; their school libraries are under attack. New Jersey is also pursuing legislation. In Louisiana, a local parish (a governmental unit equivalent to our counties) appointed book ban adherents to the local library board. Virginia now is partners with their state library association

and ties their efforts to VOTE411.org. A delegate from the Greenville, NC local League called their situation "a nightmare" and is working hard to form a coalition with like-minded non-partisan organizations. We are pleased our local League could provide this information to those delegates who are encountering problems in their states.

LWVGP was proud to represent LWVMI at the Convention and provide information on this very important topic!

Members To Vote on Senior Services Advocacy Position

The meeting to vote on the Senior Services position is scheduled for September 10 at 7 pm via Zoom. A link to the meeting will be sent to all members in early September. This meeting will have two agenda items:

- 1. Discussion from members about this position
- 2. A vote on whether to adopt it as an official LWVGP Advocacy Position

The LWVGP Bylaws require that our members vote on a position before it can be adopted. Members must receive the complete position statement within 60 days before a vote is called. This statement, along with the position paper, was sent to all members, via email, on July 5th.

In May, our Board of Directors approved the following study, *Proposed Advocacy Position: Senior Services*. Lauri Kingsbury, Advocacy Committee Chair, briefly reviewed the following position statement at the June 18 Annual Meeting.

The significant increase in the count of seniors projected over the next fifteen years in the Grosse Pointes and Harper Woods communities requires community-wide financial support from local governments and nonprofit organizations to ensure seniors have access to necessary resources and support. Essential services in public health, specifically senior services, should be integral components of each community's infrastructure to promote and protect the health and well-being of its older population.

Early Voting Now Available!

With the passage of Proposal 2 of 2022, Michiganders now have the opportunity to vote early before Election Day.

Early voting is not the same as absentee voting. Early voting is the opportunity to cast a ballot in person before Election Day. For voters, the early voting experience will be similar to the experience of voting at a polling place on Election Day and will include the act of putting your completed ballot into a tabulator. The voter can also bring his/her absentee ballot to an early voting site and insert it into the tabulator.

Early voting will take place at early voting sites. An early voting site will operate similarly to an Election Day polling place. Communities are required to offer early voting in each statewide and federal election for at least 9 consecutive days, beginning on the second Saturday before the election and ending on the Sunday before the election, for at least 8 hours each day. For the August 6 Primary, the schedule for our local communities is as follows:

- Grosse Pointe Park: Saturday, July 27 through Sunday, August 4, 8:30 am-4:30 pm-City Hall, 15115 E. Jefferson Avenue
- Grosse Pointe City: Saturday, July 27 through Sunday, August 4, 8:30 am
 4:30-City Council Chambers, 17145 Maumee Avenue
- **Grosse Pointe Farms**: Saturday, July 27 through Sunday, August 4, 8:30 am-4:30 pm—Council Chambers at City Hall, 90 Kerby Road
- **Grosse Pointe Woods**: Saturday, July 27 through Sunday, August 4, 8:30 am-4:30 pm—Community Center, 20025 Mack Plaza

- **Grosse Pointe Shores:** Saturday, July 27 through Sunday, August 4, 8:00 am-4:00 p.m.–795 Lake Shore Road
- **Harper Woods:** Saturday, July 27 through Sunday, August 4, 8:30 am-4:30 pm-19617 Harper Avenue.
