Communicating with public officials

Use the Senate or House website to find the contact information for your government official.

When you write, the following tips may help.

1. Identify a bill by proper name, contents, or number.
2. State personal position and give reasons.
3. Time the letter to arrive when issue is current.

Write letters of commendation when officials do things of which you approve.

Voting information

You are qualified to vote if:

1. You are a citizen of the United States.
2. You are 18 years of age.
3. You are a resident of Michigan and your city, township, or village for at least 30 days before election day.
4. You are not serving a sentence in jail or prison.

Absentee voting

You do not need to identify a reason to vote absentee. You can apply using one of the following methods:

- Request an absentee ballot online from michigan.gov/vote.
- Call your city clerk and ask that an application be mailed to you.
- Download an application to return by mail or in person to your local city clerk.
- Vote in person at your local city clerk's office.

Absentee ballots have deadlines. Find details at michigan.gov/vote.

Early voting

Michigan voters have the right to cast a ballot early and in person at an early voting site before Election Day.

Early voting is available for every statewide and federal election. Contact your local clerk for information on early voting sites, dates, and hours.

Running for local office

Prospective candidates for city council, school board, or municipal judge should consult their city clerk for requirements and filing dates.

Voting hours on Election Day: 7 am to 8 pm

Photo identification OR signed affidavit is required to vote in person.
